RE: Dania Beach Community Redevelopment Agency Annual Report - FY 2016

Dear Chair, Vice Chair and Members of the Board:

In compliance with Florida State Statute Ch. 163.356 of the Community Redevelopment Act, the Dania Beach Community Redevelopment Agency is required to submit and advertise its Annual Report. The statute specifically states the following:

"An agency (CRA) authorized to transact business and exercise powers under this part shall file with the governing body, on or before March 31 of each year, a report of its activities for the preceding fiscal year, which report shall include a complete financial statement setting forth is assets, liabilities, income and operating expenses as of the end of such fiscal year."

Broward County also adopted reporting rules for Municipal Community Redevelopment Agencies though Administritive Code 18.87, which require additional reporting, specifically:

"The agency shall include a comparison of Plan goals, objectives and policies to annual program accomplishments and an analysis comparing current year tax base to the base year."

Therefore, in compliance with State and County requirements, I respectfully submit the Dania Beach CRA Annual Report for Fiscal Year 2016.

## FY 2015-16 Accomplishments

The following are accomplishment so the Dania Beach CRA in FY 2015-16. The numbers in parantheses after each item are the corresponding goals and objectives identified in the City of Dania Beach Community Redevelopment Plan, 2009.

- Launched the Community Garden with garden plots for lease at the PATCH (1.c.4);
- Awarded MPO-TAP Grant for Sun Garden Isles pedestrian improvements (6.c)
- Successfully planned and implemented 4<sup>th</sup> Annual Arts and Seafood Celebration (5.b);
- Designated a Healthy Community Zone (HCZ) through BRHPC and TOUCH Partnership and completed HCZ Community Action Plans for College Gardens and Sun Garden Isles neighborhoods;
- Re-launch of Neighborhood Ambassador Program (5.b);
- Conducted 25 direct business visitations as part of Business Retention Strategy;
- Facilitated Enterprise Zone Sales Tax rebates on behalf of Casino at Dania Beach;
- Provided Merchant and Façade Incentive Grants to Stix Cigar Lounge and Olympus Premier Mobile facilities.
